Under normal conditions of use, adverse health effects are not anticipated. Due to the form of the products and low volatility, an inhalation hazard is not anticipated unless products are heated or sprayed.

These mixtures contain silica, a known carcinogen. Inhalation is the route of entry into the body that can lead to the development of Silicosis. These water-based, premixed products should be non-toxic during recommended use. Some of the pigments may contain small amounts of various forms of metals (Co, Cr), some of which are considered carcinogenic. The metals in pigments may be in form of frits, spinel or formed from high temperature calcination that may have a different bioavailability than the metal itself.
